
# ASSEMBLY INSTRUCTIONS

## STEP 1

Put STOOL LEG (A) on top of STOOL LEG (B), fasten with SCREW (G) from top and WASHER (J) and NUT (I) from bottom.

**Note:** STOOL LEG (B) has flat center on top.

**⚠** Only hand tighten SCREW (G). Do not fully tighten until finished Step 2.





## STEP 2

Once STOOL LEGS (A + B) are secured, turn legs upside down and hammer in STOOL FEET (C). Screw in FEET LEVELERS (D) into STOOL FEET (C).

Turn legs right side up. Place LARGE RING (E) around STOOL LEGS (A+B) and slide into place. Align holes on LARGE RING (E) with holes on legs, tighten with SCREW (G) from inside and CAP NUT (H) from outside.

Place SMALL RING (F) to inside of legs. Align holes on SMALL RING (F) with holes on legs, tighten with SCREW (G) from inside.



**⚠** Hand tighten ALL SCREWS first to ensure easy of alignment. Fully tighten ALL SCREWS with HEX KEY.



# ASSEMBLY INSTRUCTIONS

## STEP 3

Take out BASE PLATE (K) and turn top so that top and bottom are at a 45 degree angle. Put BASE PLATE (K) on legs. Insert SPACER (M) between BASE PLATE (K) and legs. Tighten with SCREW (L) from top, and WASHER (J) and NUT (I) from bottom.





## STEP 4

Attach SEAT RING (O) to SEAT (N) with SCREW (P). Center SEAT RING (O) by aligning holes on SEAT RING (O) with white dots on SEAT (N).

Lay SEAT (N) on ground and attach legs while stool is upside down. Attach BASE PLATE (K) to SEAT (N) with SCREW (Q).



Ensure all screws are tightened.

## CARE AND MAINTENANCE

- Do not use metal scouring pad for cleaning. Most stains can be removed by using a mild soap and a soft-bristled brush.
- Avoid placing any direct heat source on or near seat.
- This product is designed for indoor use only. Outdoor use is not recommended.

# 1 YEAR LIMITED WARRANTY

## TRINITY CHROME SWIVEL STOOL Model # TWE-1101 / TWE-11012

Trinity International Industries (“Trinity”) warrants to the original consumer purchaser (“Purchaser”) of the TRINITY Chrome Swivel Stool (“Product”) that each Product shall be free from defects in workmanship and materials for a period of 1 year from the date of original purchase. Trinity’s obligation under this warranty shall be limited to repair or replacement of, or adequate compensation for the Product which shall not be greater than the amount of the purchase price of the Product, at the option of Trinity, during the warranty period. All replaced parts and Products become the property of Trinity and must be returned to Trinity.

This warranty excludes normal wear and tear of the Product and its parts or components, and damage arising from any of the following: negligent use or misuse of the Product, use contrary to this User’s Manual, or alteration by any one other than Trinity. The warranty period of 1 year shall not be extended or renewed by the repair or replacement of, or compensation for, the Product. Any warranty implied by applicable law is limited in duration to one year from the date of purchase and is subject to the same conditions and limitations as is provided for our express warranty.

Except as set forth herein, and to the extent of applicable there are no warranties on this Product either express or implied, and Trinity disclaims all warranties including, but not limited to, any implied warranties of merchantability, infringement or fitness for a particular purpose. No warranty or guarantee given by any person, firm, or corporation with respect to this product shall be binding on Trinity.
