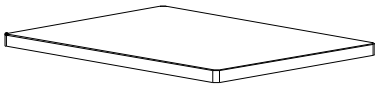

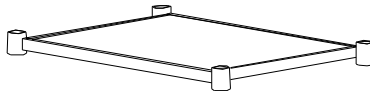

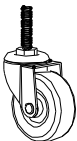

ASSEMBLY INSTRUCTIONS

STEP 1

Screw each CASTER (F & G) into bottom of each BOTTOM POLE (A). Turn clockwise to screw in place. Make sure LOCKING CASTERS (F) are on same side of Kitchen Cart.

Warning: Use provided caster wrench to tighten completely. Failure to do as instructed could result in caster stem breaking.

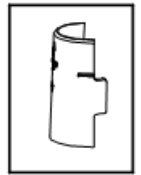


STEP 2

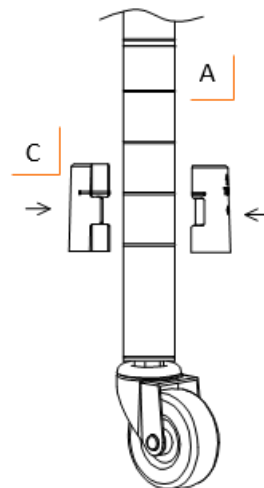
On each BOTTOM POLE (A), place one pair of SLIP SLEEVES (C) at desired height **no higher than 3rd** indentation from bottom. Make sure arrow faces up and word “TOP” is right-side up. Make sure SLIP SLEEVES (C) height is identical for each BOTTOM POLE (A).

Note that each POLE (A+B) has slight horizontal line indentations at 1” intervals. Each SLIP SLEEVE (C) has raised horizontal lines inside designed to lock in place on POLES (A+B).

Slide pair of SLIP SLEEVES (C) until you hear a click to confirm the pair is locked onto BOTTOM POLE (A). Do NOT place more than one pair on each POLE (A+B) at a time.

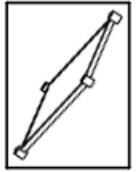


Note: There will be a very small gap in-between two locked SLIP SLEEVES (C)—this is normal.

ASSEMBLY INSTRUCTIONS

STEP 3

Place SHELF (E) on its side and slide each BOTTOM POLE (A) through each corner cylinder of SHELF (E). Make sure corner cylinders are positioned over SLIP SLEEVES (C).

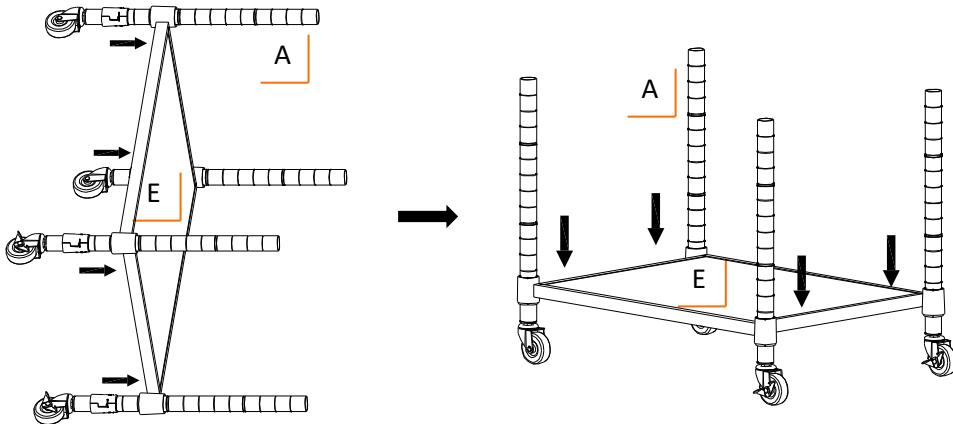

Slowly stand unit upright.

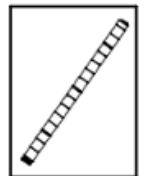
Note:

Use a rubber mallet, if needed, to secure SHELF (E).



STEP 4

Screw TOP POLES (B) into BOTTOM POLES (A) in clockwise direction.

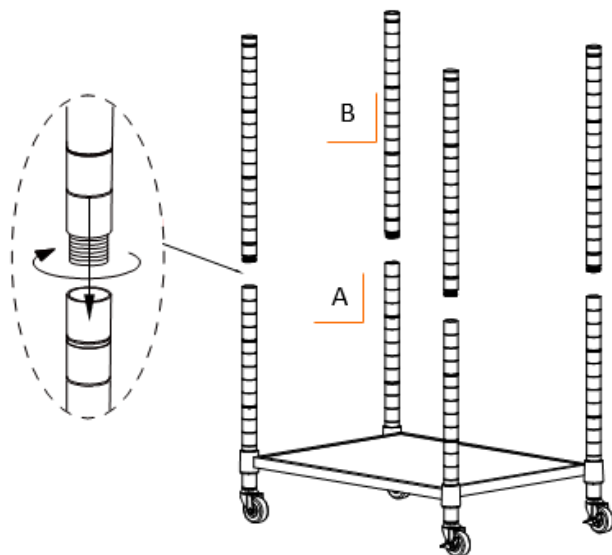

Note:

The top of each TOP POLE (B) is indicated by a BLACK END CAP.

Pole Connectors are pre-installed in bottom of TOP POLES (B).

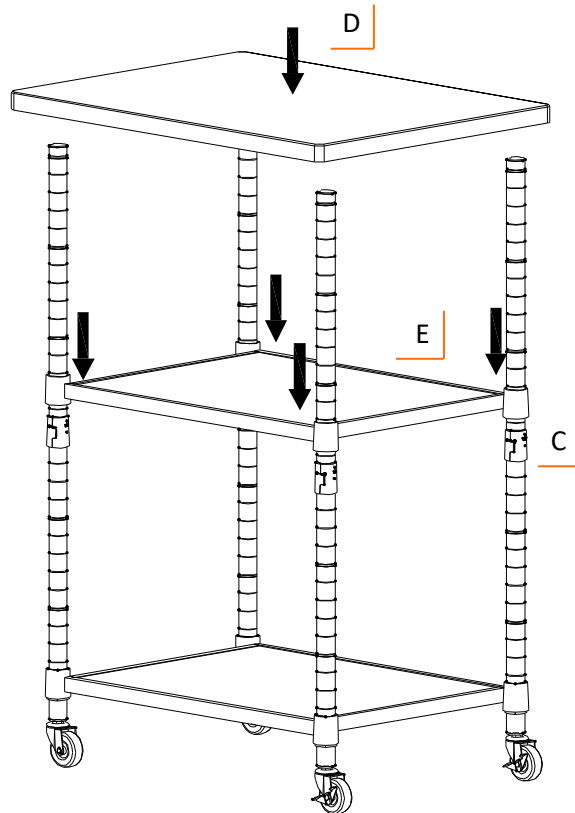
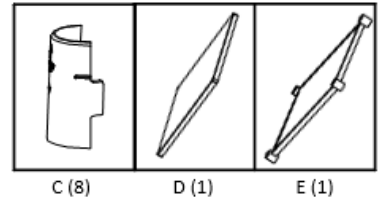
STEP 5

Repeat STEP 2 & 3 to assemble other SHELF (E). Make sure SLIP SLEEVES (C) height is identical.

Place BAMBOO CUTTING BOARD (D) on top of TOP POLES (B). Make sure top of each TOP POLE (B) is inside each corner pocket of BAMBOO CUTTING BOARD (D).

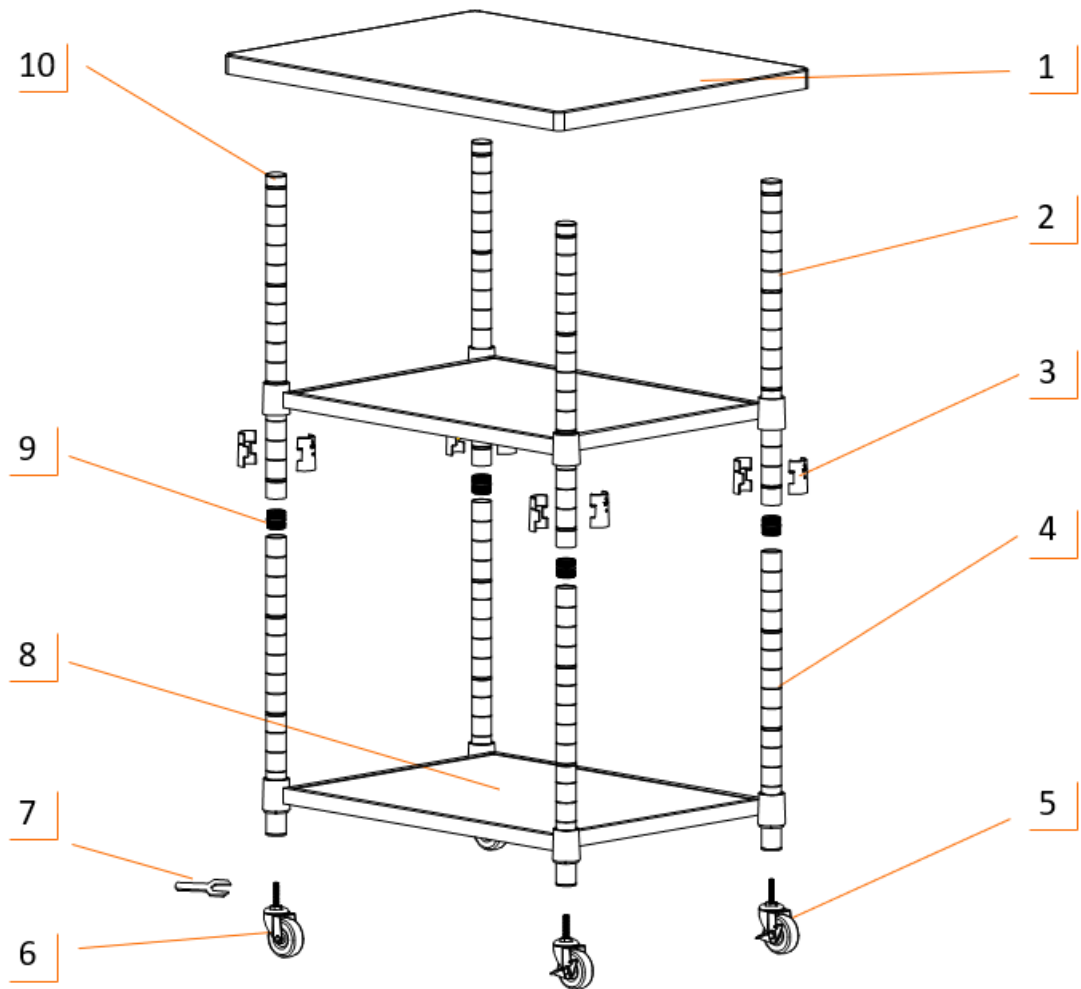
Use a rubber mallet, if needed, to secure SHELF (E).

WARNINGS

1. **Read and understand all instructions.** Failure to follow all instructions may result in injury and/or damage.
2. **Use the provided caster wrench to tighten casters completely.** Failure to do as instructed could result in the caster stem breaking thereby causing the cart to collapse.
3. **The warnings, cautions, and instructions discussed in this manual cannot cover all possible conditions or situations that may occur.** The user must always be aware of their environment and ensure that they use the product in a safe and responsible manner.
4. **Do NOT modify the product in any way.** Unauthorized modification may impair the function and/or safety of the product, and may affect the life of the product. Any modifications will void product warranty.
5. **Check for damaged parts.** Before using this product, carefully check that all parts are in good condition, and that the product will operate properly and perform its intended function. Check for damaged parts and any other conditions that may affect the operation of this product. Replace damaged or worn parts, and never use this product with a damaged part.
6. **Do NOT overload the product.**

Weight capacity on Top (evenly distributed)	150 lb
Weight capacity per Shelf (evenly distributed)	75 lb
Total weight capacity of Cart (evenly distributed)	300 lb

7. **Do NOT allow children to climb or play around the product.**
8. **Do NOT roll the product on an uneven surface. Only move the product on a smooth surface.** Rolling over rough or uneven surfaces may cause casters to break or items on the product to fall, resulting in injury and / or damage. Wood and laminate flooring can be scratched or dented. Ensure your flooring can bear the weight of loaded product before rolling loaded product across your flooring.
9. **Regularly check and secure all parts.**
10. **Do not stand on or use any part of this item as a step ladder.**
11. **Make sure that the wheels are LOCKED when using the bamboo board as a cutting or work surface.**

CARE AND MAINTENANCE

- Avoid harsh, abrasive cleaners, and other corrosive chemicals.
- Bamboo board should be hand washed only and periodically treated with food safe oil.

1 YEAR LIMITED WARRANTY

Trinity International Industries (“Trinity”) warrants to the original consumer purchaser (“Purchaser”) of the TRINITY BASICS Bamboo Top Kitchen Cart w/ Solid Shelf (“Product”) that each Product shall be free from defects in workmanship and materials for a period of 1 year from the date of original purchase. Trinity’s obligation under this warranty shall be limited to repair or replacement of, or adequate compensation for the Product which shall not be greater than the amount of the purchase price of the Product, at the option of Trinity, during the warranty period. All replaced parts and Products become the property of Trinity and must be returned to Trinity.

This warranty excludes normal wear and tear of the Product and its parts or components, and damage arising from any of the following: negligent use or misuse of the Product, use contrary to this User’s Manual, or alteration by anyone other than Trinity. The warranty period of 1 year shall not be extended or renewed by the repair or replacement of, or compensation for, the Product. Any warranty implied by applicable law is limited in duration to one year from the date of purchase and is subject to the same conditions and limitations as is provided for our express warranty.
