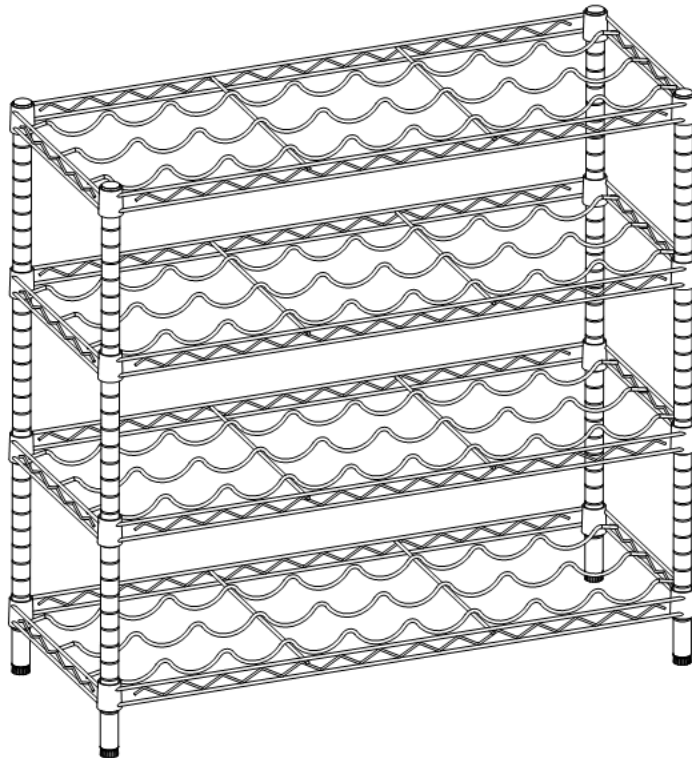

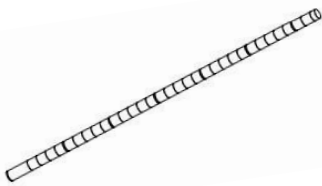

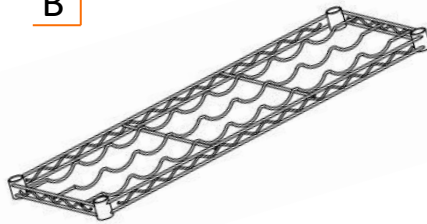

End Cap (4), Threaded Insert (4) and Feet Leveler (4) pre-installed

Only use when connecting another unit to make 8-Tier Wine Rack



Note: The black circular plastic spacers in between Shelves are used only for packaging purposes. They are NOT needed. Please discard.

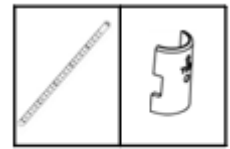
ASSEMBLY INSTRUCTIONS

STEP 1

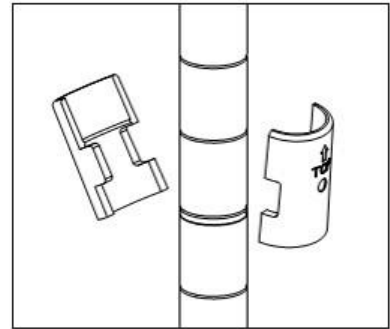
Note that each POLE (A) has slight horizontal line indentations at 1" intervals. Each SLIP SLEEVE (C) has raised horizontal lines inside designed to lock them in place on POLE (A).

On POLE (A), place one pair of SLIP SLEEVES (C) at desired height **no higher than 3rd** indentation from bottom. Please make sure arrow faces up and word "TOP" is right side up.

Slide pair of SLIP SLEEVES (C) until you hear a click to confirm the pair is locked onto POLE (A). Do this for each POLE (A) and make sure height is identical for each POLE (A). Do NOT place more than one pair on each pole at a time.

Note: There will be a very small gap in-between two locked SLIP SLEEVES (C)—this is normal.

STEP 2

Place SHELF (B) on its side and slide each POLE (A) through each corner cylinder on the SHELF (B). Make sure SHELF (B) corner cylinders are positioned over SLIP SLEEVES (C).

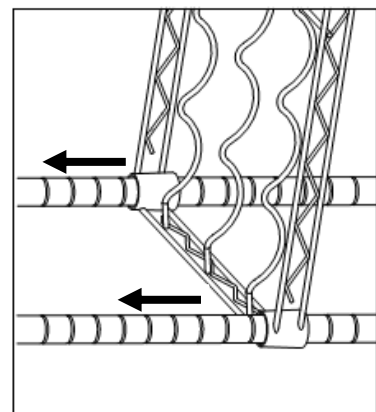
Stand the unit upright.

Note:

- Level side of SHELF (B) is TOP side (TRINITY logo on corner cylinders should be right-side up.)
- Use a rubber mallet, if needed, to secure SHELF (B).

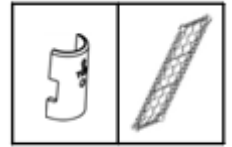

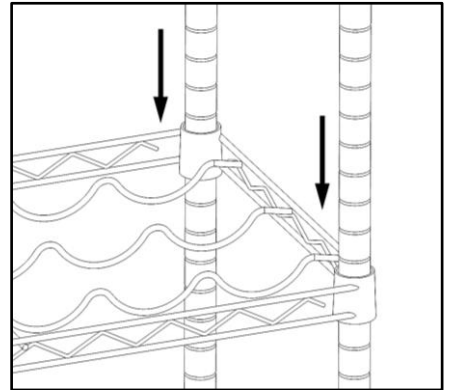

On POLE (A), place 1 pair of SLIP SLEEVES (C) at the desired distance between SHELVES (B). Please make sure the arrow faces up and that the word "TOP" is right side up. Do this for each POLE (A), and make sure height is identical for each POLE (A).

Lower SHELF (B) over each POLE (A) so corner cylinders of SHELF (B) are positioned over SLIP SLEEVES (C).

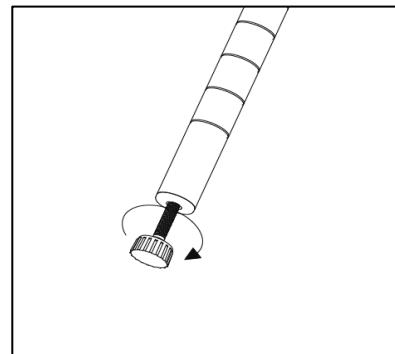
Repeat Step 3 to install other SHELVES (B) as desired.

Note: Use a rubber mallet, if needed, to secure SHELF (B).



STEP 4

Feet Levelers are already screwed into POLES (A), and you can adjust as needed to ensure Shelving Rack is level.

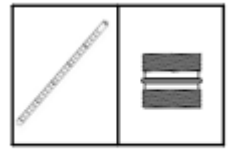
STEP 5

Purchase another TRINITY 4-TIER WINE RACK.
Fully assemble one unit first. Remove black
END CAPS from all poles.

Screw POLE CONNECTORS (D) to second unit's
loose POLES where END CAPS have been taken
off.

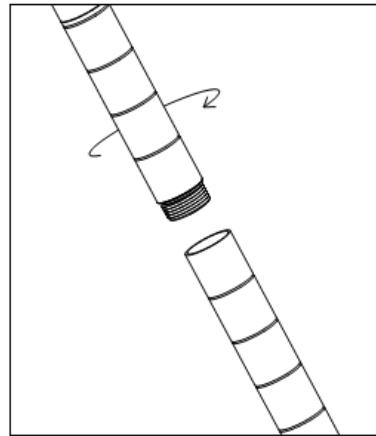
Screw POLES (A) with POLE CONNECTORS (D) to
top of POLES (A) of assembled unit.

Install remaining SHELVES (B) as desired.

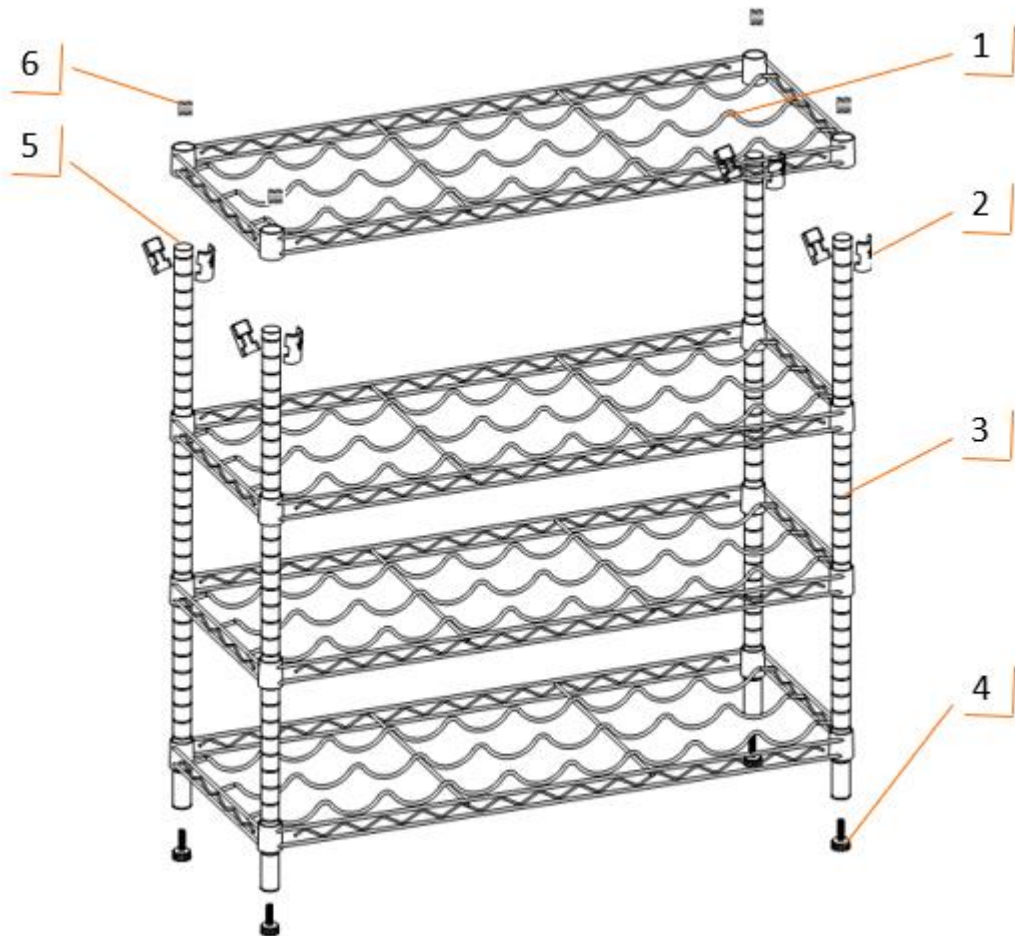

1 YEAR LIMITED WARRANTY

TRINITY EcoStorage™ 4-Tier NSF Wine Rack Model # TBFZ-0908

Trinity International Industries (“Trinity”) warrants to the original consumer purchaser (“Purchaser”) of the EcoStorage™ 4-Tier NSF Wine Rack (“Product”) that each Product shall be free from defects in workmanship and materials for a period of 1 year from the date of original purchase. Trinity’s obligation under this warranty shall be limited to repair or replacement of, or adequate compensation for the Product which shall not be greater than the amount of the purchase price of the Product, at the option of Trinity, during the warranty period. All replaced parts and Products become the property of Trinity and must be returned to Trinity.

This warranty excludes normal wear and tear of the Product and its parts or components, and damage arising from any of the following: negligent use or misuse of the Product, use contrary to this User’s Manual, or alteration by any one other than Trinity. The warranty period of 1 year shall not be extended or renewed by the repair or replacement of, or compensation for, the Product.
