WARNINGS

1. **Bins and rails may fall off and cause potential injury if not mounted properly.** Ensure rails are mounted to load bearing studs or surface. Please contact local professional contractor if unsure of the condition of the mounting surface.
2. **Failure to use proper mounting hardware can cause potential injury.** Mounting hardware not included. Each section of the rail must be secured by (2) fasteners. Use proper mounting hardware (screws and necessary anchors) for the type of surface intended. Please contact local professional if unsure of hardware needed.
3. **Do NOT modify the product in any way.** Unauthorized modification may impair the function and/or safety of the product, and may affect the life of the product.
4. **Check for damaged parts.** Replace damaged or worn parts, and never use this product with a damaged part.
5. **Bins may fall off if not hung on the rail properly.** Ensure back of the bin is fully hooked onto the rail before letting go.
6. **Do NOT overload the product.**

1 YEAR LIMITED WARRANTY

Trinity International Industries (“Trinity”) warrants to the original consumer purchaser (“Purchaser”) of the TRINITY Bin Pack (“Product”) that each Product shall be free from defects in workmanship and materials for a period of 1 year from the date of original purchase. Trinity’s obligation under this warranty shall be limited to repair or replacement of, or adequate compensation for the Product which shall not be greater than the amount of the purchase price of the Product, at the option of Trinity, during the warranty period. All replaced parts and Products become the property of Trinity and must be returned to Trinity.

This warranty excludes normal wear and tear of the Product and its parts or components, and damage arising from any of the following: negligent use or misuse of the Product, use contrary to this User’s Manual, or alteration by any one other than Trinity. The warranty period of 1 year shall not be extended or renewed by the repair or replacement of, or compensation for, the Product. Any warranty implied by applicable law is limited in duration to one year from the date of purchase and is subject to the same conditions and limitations as is provided for our express warranty.

Except as set forth herein, and to the extent of applicable there are no warranties on this Product either express or implied, and Trinity disclaims all warranties including, but not limited to, any implied warranties of merchantability, infringement or fitness for a particular purpose. No warranty or guarantee given by any person, firm, or corporation with respect to this product shall be binding on Trinity.
